

## **“Public Speaking to Influencers” (PSI) Letter Writing Campaign**

**500 PSI letters between by April 9, 2019**

**In “honor” of Duke’s 500 PSI Central Corridor Pipeline, we are having a letter writing campaign to the newly appointed voting members of the Ohio Power Siting Board, Governor Mike DeWine and Duke’s CEO Lynn Good.**

**We need to make a BIG impression so the new OPSB and Governor DeWine take notice. Help us reach our goal of 500 letters/emails/phone calls to the individuals on this list before the Adjudicatory Hearing begins on April 9<sup>th</sup>.**

**Sine OPSB Voting Members and Gov. DeWine have not been in their positions long, they are probably not aware of concerns and vehement opposition to Duke’s pipeline. We cannot afford for them to hear only Duke’s one-sided communication about this project.**

**Please help us by contacting the people below. You can write a single letter or email and send to all of them. Involve as many people as possible so that our concerns stand out despite Duke’s influence. Or call them on the phone – if you cannot speak with them directly, they usually have staff members who are responsible for learning about public concerns. Refer to Case # 16-253-GA-BTX in your communication.**

**Here is what you might want to include in your communication:**

- **How the pipeline affects you and why you are concerned**
- **Request a thorough, objective assessment of the case presented by Duke and opposing intervenors. Emphasis on whether Duke has adequately demonstrated need for a new pipeline and whether their proposed 20"/500 psi pipeline is the most responsible, financially prudent and effective solution to address Duke's stated need.**
- **Ask for a focus on human safety when considering Duke's application and case. Evaluate all alternatives for meeting Duke’s stated needs with the safety as a primary consideration.**

**Many of you have already written letters, which can be used or modified. Have your children draw a picture with a message on it (great learning opportunity! Ask members of a group to which you belong to each send letters or emails. If you are mailing letters, use colorful envelopes or stickers to help them stand out.**
